



## Valley Christian School Kindergarten – Grade 12 Win-Win Program School Year 2011-12

The Valley Christian School Win-Win program is designed to thank Valley Christian School families for their investment in the Valley Christian School community. By referring friends and families, Valley Christian School families demonstrate a sincere form of appreciation to our school. By providing tuition credit to those referring families, Valley Christian School offers a tangible way of saying thank you. A tuition credit of \$1,000 will be received to the referring family for each new full time, day school families enrolled with student Kindergarten – Grade 12. In addition the referring families will receive tuition credit for families enrolling more than one student of \$500 per additional student. A tuition credit of \$500 per new Half-time Kindergarten student referred is available.

### Valley Christian School Family Qualifications

- The referring Valley Christian School family must have attended Valley Christian School for the 2010-11 school year and be enrolled in Kindergarten through Grade 12 for the 2011-12 school year.
- If a referring Valley Christian School family withdraws from Valley Christian School prior to the time the tuition credit is received, the credit is forfeited.
- Valley Christian School teachers, staff and administrators are not eligible to receive the tuition credit.

### Referred Student Qualifications

- The new student(s) must begin school September 2011 to be eligible for Valley Christian School Win-Win Program 2011-12 discount.
- The new student or family must never have been enrolled at Valley Christian School previous to the new application date stated on this Win-Win application.
- The new student(s) must qualify under the stated Valley Christian School admissions standards and be admitted on a space available basis.
- The new student(s) must be a full time day school student and attend for at least one semester to get 1st half of credit and full year to get whole credit.
- Employees of Valley Christian School and their dependents do not qualify as a referred student or family.

### Tuition Credit

- The 50% of tuition credit will be applied directly to family accounts on statements mailed in December, the remaining tuition credit will be applied on statement mailed in May.
- The tuition credit is not redeemable for cash.
- Tuition credit may be designated for allocation directly to the referring family, split between the new and referring family, designated to another family, or designated towards Valley Christian School scholarship aid fund. The referring family must specify the tuition credit designation on the Win-Win form.
- Valley Christian School Business Office holds authority to determine qualification for credit.

### Process

1. Refer a family to Valley Christian School
2. The new family enrolls their student(s) identifying referring family during enrollment process.
3. The Valley Christian School Win-Win form is completed and signed by both the referring and the new family.
4. Submit the form to the Valley Christian School Business Office at time of new enrollment.
